Environmental Team

- 1. The Environmental Management System Management Team meets quarterly.*

2. *The Solid & Hazardous Waste Subcommittee meets every other month and takes a comprehensive approach to managing non-hazardous solid waste that encompasses waste prevention, recycling, composting and disposal programs.*
3. *The Pollution Prevention subcommittee meets quarterly and encourages source reduction or elimination as the preferred approach to environmental management at APG. The Installation is committed to reducing/eliminating the use of hazardous materials whenever feasible.*

Aberdeen Proving Ground follows federal guidelines for green purchasing. We purchase recycled content products where applicable. Purchasing of biobased products is strongly encouraged. Aberdeen Proving Ground purchases energy efficient equipment.

Aberdeen Proving Ground currently recycles automotive oil (127 tons), tires (67 tons), batteries (4 tons) and antifreeze (32 tons); scrap metal (3,792 tons); paper (295 tons); cardboard (433 tons); fluorescent light tubes (8 tons) and mercury (0.13 tons).

APG Energy Program Goals:

1. *Reduce energy use by 30% in existing facilities by 2015.*
2. *Ensure new construction and major renovation complies with the Guiding Principles for Federal Leadership in High Performance and Sustainable Buildings.*
3. *Increase the use of renewable resources to 7.5% of the total 2015 energy use.*
4. *Reduce water use by 16% in existing facilities through implementing the Department of Energy's water best management practices by 2015.*
5. *Operate the installation to support mission requirements during an emergency.*
6. *Reduce consumption of petroleum fuels 2% a year and increase the nonpetroleum fuels 10% per year in APG vehicles by 2015.*
